# Bylaws to Policy on Conflict of Interest in Medical Research Japanese Society of Nuclear Medicine

### **Article 2: Publications in the Official Bulletin of JSNM**

(Scope of Disclosure)

COI that authors are obligated to disclose are matters specified in the section 4 "Matters Requiring Disclosure" of the Policy.

(At the Time of Submission) [SEP]

Authors who submit their manuscript to Annals of Nuclear Medicine or KAKU IGAKU [Japanese Journal of Nuclear Medicine (Jpn J Nucl Med)] are required to indicate at the time of submission any potential COI by means of " Conflict of Interest Self-Declaration Form for Authors" (Supplementary Form 2) or similar document from all authors (including non-members), and " Conflict of Interest Self-Declaration Form for Authors" (Form 2) or similar document from the corresponding authors disclosing any COI within the past three-year period. Any company or organization with COI related to the content of the presentation should be acknowledged including company or organization name, funds received, and services, etc. in the Footnote of the title page or Acknowledgments of the article. In cases where no regulated COI exists, a statement such as "No potential conflicts of interest were disclosed" should be inserted in this space. With regard to COI to be clearly indicated at the time of submission, the authors are required to disclose matters as described in the section 4 of "Matters Requiring Disclosure." The monetary amount exceeding which self-declaration is required shall be the same as described in Article 1 of the Bylaws. Disclosure is required for matters pertaining to the three-year period preceding the date of manuscript submission. Authors shall submit self-declaration forms or equivalent documents to disclose any COI pertinent to publications in the journals of JSNM-related societies. The submitted Form 2 will be stored for three years after publication of the paper.

### Article 5: Criteria for Disclosure of COI

As specified in section 4 "Matters Requiring Disclosure" of the Policy, criteria for disclosure of COI are as follows:

1 Remuneration for appointment to official, advisory or employee position of companies or for-profit organizations

Annual compensation of one million yen or more from one company or organization

- 2 Ownership of stock or equity including new share subscription rights

  Annual profit of more than 1 million yen from one company, or possession of stock amounting to 5% or more of a company
- Acceptance of patent royalties or licensing fees from a company or for-profit organization One annual royalty fee of 1 million yen or more
- 4 Honoraria (such as lecture fees) from a company or for-profit organization paid as compensation for the time and/or labor of a researcher engaged in conference attendance (e.g., presentation, advice, etc.)
  - Annual fee of 500,000 yen or more from a single company or organization
- Manuscript fees paid by a company or for-profit organization as compensation for writing a pamphlet or other publication
  - Annual fee of 500,000 yen or more from one company or organization
- Research funding provided by a company or for-profit organization

  Annual total amount of 1 million yen or more paid for medical research (collaborative research, contract research, etc.) from one company or organization
- Scholarship to the declarer provided by a company or for-profit organization

  Annual total amount of 1 million yen or more paid to the declarer or the affiliated institution from one company or organization
- 8 Endowed chair provided by a company or other entities
  In case of affiliation with companies, etc.
- 9 Other remuneration (e.g., travel not directly related to research, gifts, etc.)
  Annual compensation of 50,000 yen or more from one company or organization
